- Words & Phrases (25 Marks)
(To make sentences of the given words and phrases)

PAPER V: LANGUAGE HINDI

(100 Marks)

Standard of Hindi paper shall be that of matriculation examination of Haryana Board.

It shall comprise of:

- Translation of English passage into Hindi. (20 Marks)
